~ Jim VanDyne addressed the board concerning numerous large fireworks being shot off on the fourth of July down at the boat ramp. He stated that for 2 years in a row this has been happening. VanDyne said that he called county dispatch and was informed that the LPPD was tied up with Fireworks being set off in town and could not respond. He also stated that someone had a fake Facebook page and posted on there all the fireworks that they had set off, and a day later the page was taken down. VanDyne voiced his concern that this will become common practice and that something needs to be done regarding this and that a police officer needs to be present at the launch area at that time. ~

~ Chris Buchleitner commented that the bike parade was awesome, and the picnic afterward was wonderful. She was concerned however that during the parade one of the floats shot off confetti cannons and that it left a terrible mess in the street. Residents let her know that while some residents cleaned up the debris from their yards, others do not and the material gets down into the drains and creates clogs and other issues. She is asking that the Township ask participants to refrain from any such debris being put onto the streets in the future.
