# LAWRENCE PARK TOWNSHIP BOARD OF COMMISSIONERS MEETING

- $\sim$ Commissioner Rodemaker called the meeting to order at 6:00 p.m. The Pledge of Allegiance to the Flag was performed and a moment of silence was observed for the victims and heroes of 9/11  $\sim$
- \*A public meeting regarding the application for a Liquor License transfer by Erie Royal, LLC from Harborcreek to Lawrence Park Township was held. Solicitor Sunberg spoke on behalf of Erie Royal stating that the intention is to open a restaurant which will offer seating for thirty-five. This is an economic development project creating construction jobs and new employees to work the restaurant. This will be a family-oriented establishment offering food for those going to and from sporting and school events. This will be a visual and economic improvement for the Township. Rose Nouri spoke to the Board and Residents regarding the business would be open from 5 am until 11 pm seven days a week. This business will be able to compete with Country Fair and GetGo. Commissioner Golden asked if it was the intention to sell alcoholic beverages "to go." Mrs. Nouri said that this will be the goal to do this. She also stated that the sales of such items will be highly monitored. Commissioner Buchleitner asked if the PLCB has weighed in yet, Solicitor Sunberg said that they cannot move forward until the Township Board approves the transfer of the liquor license. Mrs. Nouri stated that parking will be on one side of the building and the gas station will be on the other side. Police Chief asked about traffic flow, Mrs. Nouri said that primary entrance and exit is on the Main Street side of the property. Commissioner Benovic asked about the proximity of the business particularly with the sale of alcohol concerning the school. Solicitor Sunberg stated that all these things will be addressed during the permitting process and with the PLCB.
