~Commissioner Rodemaker called the meeting to order at 6:00 p.m. The Pledge of Allegiance to the Flag was performed~

Commissioner Rodemaker gave the floor to Mr. John Kraus and John Clark from Allegheny Financial who presented the Board with the financial reports for Uniformed and Non-Uniformed pension plans. The economy is in better shape and the plans are on the way up. Kraus recommends to keep the plans as they are.

Police Report:

Chief Morell stated the police responded to 917 calls this past month and that this has been the highest call record the PD has ever had. Chief stated that a drug arrest came back positive for xylazine, and this is the first time he has seen it in the Erie area. This drug is considered a "zombie" drug that is derived from a horse tranquilizer. Chief stated that this is very alarming that it is now in Erie. This is the first report in Erie and was taken from a Lawrence Park traffic stop.

• Commissioner Williams made a motion to approve BOC Minutes from July 10, 2024, Commissioner Rodemaker seconded the motion; the motion carried.

New Business:

- Commissioner Buchleitner made a motion to hire Gerard Wodarski as seasonal crossing guard once his clearances are furnished; Commissioner Rodemaker seconded; the motion carried.
- Commissioner Buchleitner motioned to advertise the Budget meetings beginning 9/16 12/2 every Monday night from 5-7 pm. Commissioner Rodemaker seconded; the motion carried.

- Commissioner Buchleitner reported that spending has remained on track. There have been upgrades to the Township office and Police Department I.T. systems and the Township is now on a cloud-based program. There has been maintenance done to the Township equipment by our own maintenance crew thus improving our ability to continue daily needs. Buchleitner stated the Township has contracted with Grass Root through the DCED Stamp Program which is helping to look at a 5-year plan for the Township regarding every area and every department performance. Buchleitner encouraged residents to attend the budget meeting sessions to see what is being looked at and the budgeting process for the coming year. Commissioner Buchleitner also said the Centennial Celebration could use residents to help with every aspect of this day to make it more memorable for everyone.
- Commissioner Benovic reminded the residents Shakespeare in Napier Park will take place August 19, 20 and 21. Benovic also reported that the National night out was a success and was thankful for the LPPD for full participation that evening.
- Commissioner Rodemaker updated the residents regarding all the upgrades that have been made up to date concerning the lift stations as well as the continued maintenance to sewer lines within the Township.
