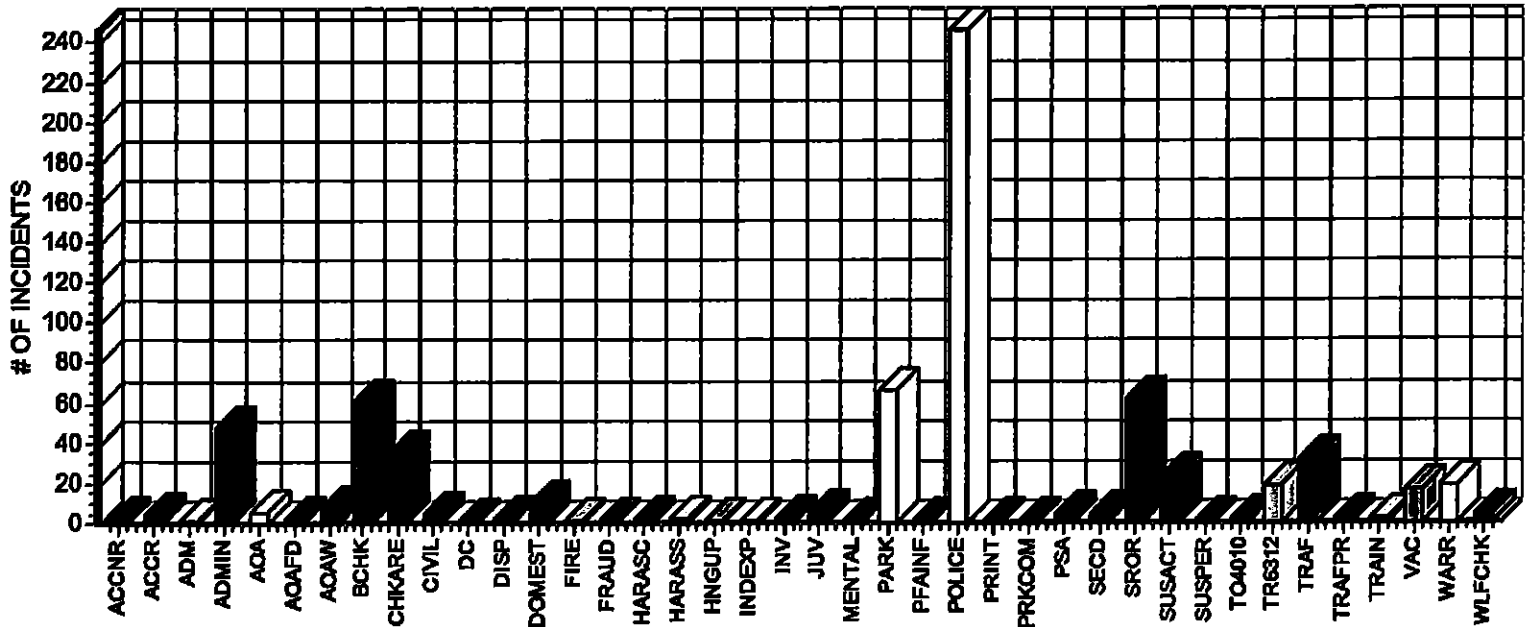

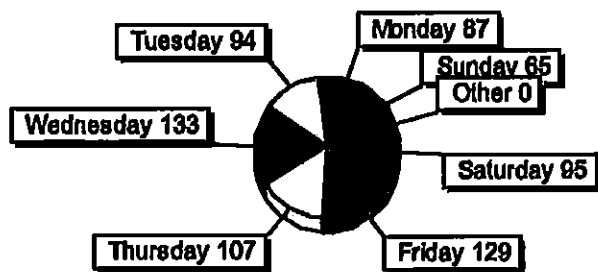

Incident Frequency by TYPE (Top 40 of 45 Shown) (Using DATE RECD)



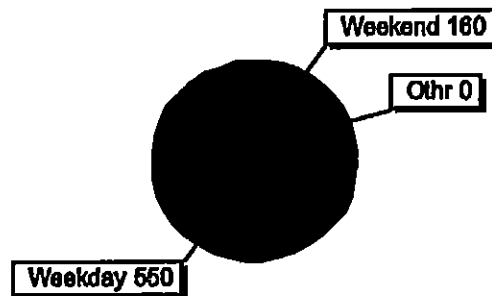
